**General Instructions:**

1. The registration will be confirmed on **1st come 1st serve basis** only on filing the Registration Form. The payment of fees will not suffice.
2. It has been decided by ICAI RVO to charge a nominal registration fees as most of the members register for the training and do not attend the same. This has happened in most of the online CEP trainings conducted by ICAI RVO.
3. The registration fee is non-refundable.
4. The CEP training details will only be hosted on ICAI RVO website. (As many

members complain they don't receive mails from ICAI RVO or do not see the mails frequently, and by the time they respond the seats are already full).

5. The video of the participant during the session must be compulsorily "**ON**" as per directions of IBBI.
6. The attendance of the participant may not be captured if the video is "**OFF**" during the training.
7. The participant is required to login with his/her Name or ICAI RVO Membership no. so that his/her attendance may be marked as we have noticed many times the participants login with some other names.
8. As per IBBI Guidelines we can accommodate only 100 participants in one batch and the registrations will be closed after 100 participants.
9. Participant may attend the training from their laptop/desktop with camera and should have a stable internet connection.
10. Participant will not be allowed to access the training after 15 minutes from the start of the session except for certain unavoidable reasons to be recorded in writing.
